What happens next?

- 1) Following receipt of your deposit we will confirm your booking details in writing. This will detail the agreed costs and provide you with a date by which the final payment is due.
- 2) We will send a reminder, where necessary, 7 days before of the final payment date.
- 3) Following receipt of the final payment we will send you the full instructions for your stay.

BOOKING CONDITIONS

1. The person signing the booking form (lead name) shall be deemed to be signing on behalf of all members of the party, who agree to be bound by these booking conditions. Cancellations must be made in writing and will be accepted only from the lead guest.
2. All accommodation and facilities are for persons named on the booking form only; no other persons are authorized to use the accommodation or facilities.
3. A non-refundable deposit of £100 sterling per week is required with this form to confirm booking.
4. Full payment, including a fully refundable bond of £100 per week, to be paid 8 weeks prior to departure, or at the time of confirmation if booking within 8 weeks of departure.
5. The bond is fully refundable on receipt of a damage free report from the villa management company.
6. If full payment is not received 8 weeks prior to the departure date the villa owners may cancel the booking without warning.
7. The villa owners are not responsible for any loss of vacation time in the villa due to conditions beyond their control.
8. The property has a swimming pool & spa - the owners do not accept any liability for injury or death caused during their use. Guests are required to observe the pool rules and to ensure patio door alarms are activated at all times.
9. The owners accept no liability for the loss or theft of clients' personal items from the property.
10. The property will be available from 16:00 on arrival day and must be vacated by 10:00 on departure day, unless specific alternative arrangements are made with the management company.
11. No smoking or pets are allowed inside the villa.
12. Cancellation terms: Deposit is non-refundable.
50% of all other payment is refundable if written notification is made providing a minimum of 28 days notice prior to agreed departure date. Within 28 days of departure no refunds are possible.
